

Tips to Use ShepherdAI:

Daily protocols that will multiply your growth:

- 1. Wake up at 4 am.
- 2. Immediately drink a glass of water.
- 3. Take a cold shower; at least long enough to take 30 deep breaths.
- 4. 15 minutes of postured prayer (kneeling).
- 5. Read scripture for 15 minutes minimum, & write down questions & personal convictions you have while reading.
- 6. Research questions & write how you should respond to the convictions you had while reading.
- 7. Complete at least 1 section every two weeks.
- 8. Exercise at least 3-4 times per week for at least 1 hour per session, with at least 10-15 minutes of cardio and listen to scripture while doing cardio.
- 9. Stretch for 3 minutes minimum after exercising, then do a breathing exercise before taking a cold shower and continuing with your day.
- 10. Work hard at work, relationships, and respecting your neighbors.
- 11. Improve your diet.
- 12. Spend 15 minutes in postured prayer before sleep.
- 13. Find at least one man to do this devotional with, and get together at least once every two weeks to spend time, have coffee, exercise, or reflect.
