- 1. In the box where it says, **"Ask Anything"**, type a question/ prompt then press "Enter" or click the arrow to send.
- 2. Click, **"New Chat"**, when asking questions relating to different topics, or providing new context.
 - a. **Tip**: For improved accuracy, start a new chat after 5-10 messages sent on one chat thread.
- 3. Click "Theme", to choose "light" or "dark" mode.

Tips to Use ShepherdAl:

Daily protocols that multiply growth:

- 1. Consistently wake up at a set time (i.e. 4 am), aiming for 7-8 hours of sleep.
- 2. Drink a glass of water upon waking up.
- 3. Take a cold shower, lasting for 15 deep breaths or the duration of "The Lord's Prayer" plus a prayer for others.
- 4. Engage in 3-15 minutes of prayer in a kneeling posture. Invite spouse, family, roommates to join.
- 5. Read scripture for a minimum of 15 minutes, noting questions, personal convictions, and a verse to contemplate throughout the day. Spend a few minutes searching for answers to your question & then write about how you should act considering your convictions & insights.
- 6. Complete 1-2 Questions from the devotional daily. 1 section might take roughly two weeks to complete.
- 7. Exercise for 45 minutes, 3-4 times per week, incorporating 10-15 minutes of cardio while listening to scripture (proverb, psalm, gospel, etc.). No breaks betweens exercises. Keep moving & toughen up.
- 8. Do 7 stretches post-exercise, followed by a breathing exercise before a cold shower, then continue the day.
- 9. Dedicate effort to work, relationships, respecting others, and serving the most needy in your community.
- 10. Make dietary improvements, be an role model. Your physique speaks volumes.
- 11. Spend 3-15 minutes in prayer before bedtime. Invite others to join.
- 12. Find a partner for this devotional routine, meeting at least once every two weeks for coffee, exercise, reflection, etc.

First and foremost, our love for others is, in part, exactly what brings glory to God. It is a discipline best displayed when born out of a desire to please and honor God and delight in His ways, living as the salt and light of the earth.

Enhances overall health and vitality, sets a positive example for others, supports long-term well-being, reduces the risk causing harm to the body God gave us, and postures us, in as much as it is in our hand to do so, to serve with strength throughout all of the days of our life. It is also an act of spiritual warfare against gluttony, lust, and idolatry, through self-control. In each place of our

Promotes relaxation and better sleep, fosters peace of mind and gratitude, and is a time to meditate on His word, hear from Him, and seek His council, comfort, and providence, as we share all of our struggles, errors, and faults, hidden and intentional, and are cleansed through the work of the Spirit.

Provides mutual support and accountability, fosters deeper connections and understanding, encourages consistency and commitment. Iron sharpens iron, whether you partner with your spouse, friend, sibling, grandchild, someone you're dating, etc.

Use your weight or even BMI as a place-marker as a physical test to measure your improved selfcontrol. Determine what would be a healthy weight for your age, height, and sex. Set a goal to reach, then determine what you'll do daily to get there, how you'll know you're on track week after week, and watch your progress from month to month, year to year.

Did you hit your goal? What were some daily habits that helped or prevented this? Ask God for wisdom, talk with others, friends or professionals, who may provide you insight into a pattern of life that will help you grow spiritually, mentally, and physically. This is not about earning favor for yourself or from others, it is about glorifying God in every aspect of your life, including your diet, exercise, and habits of selfdiscipline, mental fortitude, will.

Concisely write what you're aiming for. What sort of growth would you like to see. Could you improve your work ethic? Where do you struggle with lust? Is it for food, indulgence, bad habits, fleshly desires, or in choosing the good option instead of the best? Are you able to admire the success of others, applaud their hard work and learn from them, or do these sorts of things foster bitterness or even envy? Are you able to give of your time, talent, and treasure, as unto God, and live charitably, while still being wise? In what ways has God stirred up your heart to deal with pride? In what ways does it manifest itself in you? How often do tell God the wrong you willfully do? How about anger or recklessness? What poor habits have you yet to notice?
